In Exercise of Powers conferred under Section 26 of the ‘Gujarat Private Universities Act, 2009 (Gujarat Act No.8 of 2009)’, the Governing Body of the University hereby makes following ‘Statutes’. These Statutes may be called “The First Statutes of Noble University”.

<p>Section 1 of GPUs Act, 2009</p>	<p>1.1 Short Title & Commencement</p> <p>i. This "Statutes" may be called the First Statutes of Noble University.</p> <p>ii. These statutes shall come into force with effect from the date of publication by the Government of Gujarat in its Official Gazette.</p> <p>iii. The Statutes are pursuant with the provisions of the Gujarat Private Universities Act, 2009 and its amendments. In case of any changes in provisions of the Act or the Rules or the Statutes, the provisions of the Act or Rules made under the Act shall prevail.</p> <p>iv. Nothing in these Statutes shall be deemed to bar the University from amending the Statutes subsequently according to the provision of Section 27 of the Act and the amended Statutes, if shall be applicable with immediate or prospective effect from such date as prescribed in any, the notification and prior approval from the State Government.</p>	
<p>Section 2 of GPUs Act, 2009</p>	<p>1.2 Definitions</p> <p>(1) In these Statutes, unless context otherwise requires: -</p> <p>(a) “Act” means, The Gujarat Private Universities Act, 2009 as amended from time to time;</p> <p>(b) “Academic Year” means the period from 1st July of any year to 30th June of the following year or another period of 12 months;</p> <p>(c) “Committee” means all committees including Ad-hoc and Sub-committees under Section 25 of the Act;</p> <p>(d) “Authorities” mean authorities as specified in Section 19 of the act and include authorities declared by these Statutes;</p> <p>(e) “Academic Council” means the Academic Council constituted under the provision of Section 22 of the Act;</p> <p>(f) “Governing Body” means the governing body of the University constituted under the provision of Section 20 of the Act;</p> <p>(g) “Board of Management” means the Board of Management of the University constituted under the provision of Section 21 of the Act;</p> <p>(h) "Regulatory Body" means a body established by the Central Government, for laying down the norms and conditions for ensuring academic standards of higher education, such as UGC, AICTE, NCTE, MCI, PCI, NAAC, ICAR, DEC, CSIR;</p> <p>(i) “Course” means academic programmes and courses of studies imparted in the classroom and also in blended / composite mode;</p> <p>(j) “Financial Year” means the period commencing on the 1st April of any year and ending on 31st March of the following year;</p> <p>(k) “Endowment Fund” means a funds established under the provision of Section 36 of the Act;</p>	

	<p>(l) “Government” means the Government of Gujarat;</p> <p>(m) “General Fund” means the fund established under the provision of Section 37 of the Act;</p> <p>(n) “Institute” means any Institute constituted as part of the university to deal in different disciplines located within the campus of the university;</p> <p>(o) “President” means the President of University appointed by the Sponsoring Body of the university in consultation with the State Government under the provision of Section 14 of the Act;</p> <p>(p) “Provost” means the Provost of the University appointed under the provision of Section 15 of the Act;</p> <p>(q) “Registrar” means the registrar of the university appointed under the provision of Section 16 of the Act;</p> <p>(r) “Regulations” mean the Regulations made under the provisions of Statutes of the University;</p> <p>(s) “Rules” mean the Rules made under the provisions of Statutes of the University;</p> <p>(t) “Ordinances” mean the Ordinances of the University made under the provision of Section 28 of the Act;</p> <p>(u) “Statutes” mean the statutes made under Section 26 of the Act and include the amendments, modifications and alterations of the Statutes made under Section 27 of the Act;</p> <p>(v) “Sponsoring Body” means the Sponsoring Body, Shri Vivek Bharti Trust;</p> <p>(w) “Student” means a student of the University and includes any person who is enrolled to pursue any course or study offered by the University;</p> <p>(x) “University” means Noble University, Junagadh, Gujarat established under the provision of Section 3 of the Act and will have the same meaning as defined in Section 2 (f) of the University Grants Commission Act, 1956;</p> <p>(y) “Staff” means the teaching and non-teaching staff of the University who are on direct and permanent payroll of the University and does not include any casual, temporary, contractual, ad-hoc employees or visiting faculty who may be engaged for a specific assignment / project or task;</p> <p>(z) The words and expressions used herein and not defined in the Statutes will have the same meaning as assigned to them in the Act;</p>	
	<p>1.3 Objects of the University</p> <p>The objects of the University shall be to create, organize, preserve and disseminate knowledge in the fields of Sciences, Technology, Humanities, Social Sciences, Education, Management, Commerce, Law, Pharmacy, Skill & Vocational, Healthcare, Paramedical, Allied Health, Medical and any other field and to provide research, higher education, professional education, distance learning and e-learning facilities of high order, as per their current status or as they may develop in future. In short, to establish state of art facilities for education and training and other objects of the University shall be as follows, namely:-</p>	<p>Section 4 of GPUs Act, 2009 and Section 3 of GPUs (Amendment) Act, 2021.</p>

	<ul style="list-style-type: none"> (a) to provide for instruction, teaching and training in the University in the field of higher education and make provisions for research, advancement and dissemination of knowledge; (b) to establish, maintain and manage institutions and centers of excellence, to create, organize, preserve and disseminate knowledge in the fields of Sciences, Technology, Humanities, Social Sciences, Education, Management, Commerce, Law, Pharmacy, Skill & Vocational, Healthcare, Paramedical, Allied Health, Medical and any other field and to provide research, higher education, professional education, distance learning and e-learning facilities of high order, as per their current status or as they may develop in future. In short, to establish state of art facilities for education and training.; (c) to develop infrastructure for research, higher education, professional education, teaching, training, extension and outreach, including continuing education, distance learning and e-learning to create capabilities for upgrading infrastructure to global standards; (d) to offer the academic programmes of the University through, distance education, online education, correspondence and any other mode matching with the environmental developments such as technology need, after obtaining appropriate approvals from the regulatory bodies; (e) to set up off-campus centers, study centers and examination centers within the State, subject to the permission of the regulatory bodies under any law made by the Parliament and any regulation, rules, etc. made by the regulating bodies; (f) to create higher levels of intellectual abilities; (g) to establish state of the art facilities for education and training; (h) to carry out teaching and research and offer continuing education programmes; (i) to create centers of excellence for research and development and for sharing knowledge and its application; (j) to provide consultancy to the industry and public organisations; (k) to establish main campus or infrastructure in the State of Gujarat necessary for the furtherance of its objects; (l) to establish examination centers; (m) to confer degrees, diplomas, grant certificates and other academic distinctions on the basis of examination or any other method of evaluation subject to the guidelines of the UGC; (n) to develop training facilities in the field of higher education; (o) to provide for arrangement for national and global participation in the field of higher education; (p) to develop educational programmes for certificates, diplomas, degrees and postgraduate courses, doctorate degrees and postdoctoral programmes and to maintain a high standard of education, to collaborate with national and global institutions, to offer programmes and to create capabilities for upgrading programmes to the global standards subject to the guidelines of the UGC;

	<p>(q) to ensure that the standard of the degrees, diplomas, certificates and other academic distinctions are not lower than those laid down by AICTE, NCTE, UGC, BCI, RCI, MCI and Pharmacy Council and any other similar agency established by the Central Government for regulating the standard education;</p> <p>(r) to establish close linkage with the industry, business, educational institutions and other sections of the society to make teaching, research, training, documentation, publication, use of various media and outreach activities at the University relevant to the needs of the University and society, at national and international level;</p> <p>(s) To collaborate with other Universities, Research Institutions, Industries, Government and other organisations of the nation and over sea countries towards the fulfillment of the University objectives;</p> <p>(t) To offer Degree Programmes jointly with other Degree granting Universities / institutions; both, Indian or Foreign, provided that such institution(s) is/are properly accredited in their home country and with the prior approval of the State Government and the competent regulatory body from time to time.</p> <p>(u) To attract candidates for various courses from other states and overseas countries for better interaction among students from different cultures.</p> <p>(v) to pursue any other objectives as may be approved by the State Government from time to time:</p> <p>Generally, the prime object of the university shall be to promote education in all the fields.</p> <p>Provided that notwithstanding anything contained in the Act and save as provided in any Central Act, the University shall be eligible to undertake the functions of disseminating of knowledge in any fields after the Government issues Letter of Intent”.</p>	
	<p>1.4 Powers and Functions of the University</p> <p>The University shall exercise and perform the following Powers and Functions, namely;</p> <p>i. To administer and manage the University, establish, administer and manage its constituent colleges and centers for research, education, training, extension and outreach including continuing education, distance Learning and e-learning at its campus within the State of Gujarat;</p> <p>ii. To provide for research, higher education, professional education, teaching, training, extension and outreach including continuing education, distance learning and e-learning in the fields of Sciences, Technology, Humanities, Social Sciences, Education, Management, Commerce, Law, Pharmacy, Skill & Vocational, Healthcare, Paramedical, Allied Health, Medical and any other field;</p> <p>iii. To conduct innovative experiments in educational technologies, teaching and learning methods, to collaborate with national and international institutions and to offer joint programmes with such institutes to constantly improve the delivery of education and to achieve international standards of education;</p>	<p>Section 5 of GPUs Act, 2009 and Section 4 of GPUs (Amendment) Act, 2021.</p>

	<ul style="list-style-type: none"> iv. To prescribe courses, curricula and methodologies for electronic and distance learning and provide for flexibility in the delivery of education; v. To hold examinations and confer degrees, diplomas or grant certificates and other academic distinctions or titles on persons subject to such condition as the University may determine and to withdraw or cancel any such degrees, diplomas or certificates and other academic distinctions or titles in the manner prescribed by the Regulations; vi. To confer honorary degrees or other distinctions in the manner prescribed by the Statutes or Ordinances; vii. To establish schools, centers, institutes, colleges and conduct the programmes and courses of study as are in the opinion of the University, necessary for the furtherance of its objects; viii. To declare as a constituent college any college, center institution imparting education as are in the opinion of the University, necessary for the furtherance of its objects or to establish a new constituent college, center institution for the purpose; ix. To provide for printing, publication and reproduction of research, educational material and other works and to organize exhibitions, conferences, workshops and seminars; x. To establish knowledge resource center; xi. To sponsor and undertake research and educational programmes in the fields of Sciences, Technology, Humanities, Social Sciences, Education, Management, Commerce, Law, Pharmacy, Skill & Vocational, Healthcare, Paramedical, Allied Health, Medical and any other field; xii. To collaborate or associate with any educational institution with like or similar objects; xiii. To establish campuses including virtual campus for the purpose of achieving the objectives of the University subject to the approval of the regulatory bodies; xiv. To undertake research and to obtain registration in respect of such research in the nature of patents, design rights and such or similar rights with the competent authorities; xv. To maintain linkages and collaborate with educational or other institutions in any part of the world having objects wholly or partially similar to those of the University, through exchange of students, researchers, faculty and staff and generally in such manner as may be conducive to their common objects; xvi. To render services of research, training, consultancy and such other services as required for the purposes of the University; xvii. To develop and maintain relationships with faculty, researchers, administrators and domain experts in Sciences, Technology, Humanities, Social Sciences, Education, Management, Commerce, Law, Pharmacy, Skill & Vocational, Healthcare, Paramedical, Allied Health, Medical and any other field for achieving the objects of the University; xviii. To regulate the expenditure and to manage the finances and to maintain the accounts of the University;

To receive funds, movable and immovable properties, equipments, software and other resources from business, industry, other sections of society, national and international organisation or any other source by transfers or as gifts, donations, benefactions or bequests for the purposes and objects of the University;</p> <p>xx. To establish, maintain and manage halls, hostels for students and quarters for the residence of faculty and staff;</p> <p>xxi. To construct, manage and maintain centers, complexes, auditorium, buildings, stadium for the advancement of sports, cultural, co-curricular and extra-curricular activities;</p> <p>xxii. To supervise and control the residence and regulate the discipline of students, faculty and staff of the University and to make arrangements for promoting their health, general welfare, social and cultural activities;</p> <p>xxiii. To fix, demand and receive or recover fees and such other charges as may be prescribed by the Statutes or Ordinances;</p> <p>xxiv. To institute and award fellowships, scholarships, prizes, medals and other awards as may be prescribed by the Statutes or Ordinances;</p> <p>xxv. To purchase or to take on lease or accept as gifts, bequests, legacies or otherwise any land or building or works which may be necessary or convenient for the purpose of the University and on such terms and conditions as it may think fit and proper and to construct or alter and maintain any such building or works;</p> <p>xxvi. To sell, exchange, lease or otherwise dispose of all or any portion of the properties of the University, movable or immovable, on such terms as it may think fit and consistent with the interest, activities and objects of the University;</p> <p>xxvii. To draw and accept, to make and endorse, to discount and negotiate promissory notes, bills of exchange, cheques and other negotiable instruments;</p> <p>xxviii. To raise and borrow money on bond, mortgages, promissory notes or other obligations or securities founded or based upon all or any of the properties and assets of the University or without any securities and upon such terms and conditions as it may think fit and to payout of the funds of the University, all expenses incidental to the raising of money and to repay and redeem any money borrowed;</p> <p>xxix. To invest the funds of the University in or upon such securities and transpose any investment from time to time in such manner as it may deem fit in the interest of the University;</p> <p>xxx. To execute conveyances regarding transfers, mortgages, leases, licenses, agreements and other conveyances in respect of property, movable or immovable including Government securities belonging to the University or to be acquired for the purpose of the University;</p> <p>xxxi. To admit students for the courses offered by the University in the manner prescribed by the Ordinances;</p> <p>xxxii. To create academic, technical, administrative, ministerial and other posts prescribing qualifications by the Ordinances and to make appointments thereto;</p>

	<p>xxxiii. To regulate and enforce discipline among the students, employees of the University and to provide for such disciplinary measures as may be prescribed by the Regulations;</p> <p>xxxiv. To institute professorships, associate professorships, assistant professorships, readerships, lectureships and any other teaching, academic or research posts and to prescribe by the Statutes or Ordinances, the qualifications for the persons to be appointed on such posts;</p> <p>xxxv. To appoint qualified persons as professors, associate professors, assistant professors, readers, lecturers or as teachers and researchers or other officers of the University;</p> <p>xxxvi. To cooperate with other Universities and acquire membership of, bodies, authorities or associations, which may have been formed for the advancement of learning, science or research or for the dissemination of knowledge or for the physical and moral welfare of students, in such manner and for such purpose as the University may determine by Statutes or Ordinances;</p> <p>xxxvii. <p>Section 12 of GPUs Act, 2009</p>	<p>1.5 University open to all irrespective of sex, religion, class, creed or opinion</p> <p>1. No person shall be excluded from any office of the University or from membership of any of its authorities or from admission to any degree, diploma or other academic distinction or course of study on the ground of sex, race, creed, class, caste, place of birth, religious belief or political or other opinion.</p> <p>2. It shall not be lawful for the University to impose on any person any test whatsoever relating to sex, race, creed, class, caste, place of birth, religious belief or political or other opinion in order to entitle him to be admitted as a student or to hold any office or post in the University or to qualify for any degree, diploma or other academic distinction or to enjoy or exercise any privileges of the University or any benefaction thereof.</p>

This declaration is made in adherence to the provisions outlined in the Gujarat Private Universities Act, 2009.</p>

	<p>2.1 The President</p> <ul style="list-style-type: none"> (1) The President shall be appointed by the Sponsoring Body, in consultation with the State Government, for a period of three years by following such procedure and on such terms and conditions as may be prescribed by the Statutes. The President may be reappointed for the subsequent years. (2) The President shall be the head of the University. (3) The President shall preside at the meetings of the Governing Body and at the convocation of the University for conferring degrees, diplomas or other academic distinctions and in his absence by any other member of the Governing Body nominated by it. (4) The President shall have the following power namely:- <ul style="list-style-type: none"> (a) to call any information or record; (b) to appoint Provost; (c) to remove Provost in accordance with the provisions of Sub-Section (6) of section 15 of the Act; (d) such other powers as may be prescribed by the Statutes. <p>Note: In accordance with Sub-Section (4)(d) of Section 14 of the Gujarat Private Universities Act, 2009, NOBLE University is pleased to declare the other powers of President. This declaration is made in adherence to the provisions outlined in the Gujarat Private Universities Act, 2009.</p> <ul style="list-style-type: none"> (e) To preside over the meetings of the Governing Body, the Board of Management and the Finance Committee. (f) To nominate any other member of the Governing Body in his/her absence for presiding over the Convocation function (g) To be the final authority in case of any decisions taken by the Provost under Sub-Section 4 of Section 15 of the Act and the same are questioned by the authority of the University which otherwise deals with the matter in normal course. (h) The President shall have powers to call for any information from any authority of the University (i) The President shall have powers to appoint the First Provost and other officers of the University. (j) The President shall have powers to remove the Provost in accordance with the provisions of Sub-Section (6) of Section 15 of the Act 	<p>Section 14 of GPUs Act, 2009 and Section 6 of GPUs (Amendment) Act, 2021.</p>

	<p>(k) The President shall provide general guidance and directions for laying down policies for functioning of the University</p> <p>(l) Every proposal to confer an honorary degree shall be subject to the confirmation of the President.</p> <p>(m) The President shall have powers to make the First Ordinances of the University which shall be approved by the Board of Management and subsequently by the State Government in accordance with the provisions of Sub-Section (2) of Section 28 of the Act.</p>	
<p>Section 15 of GPUs Act, 2009</p>	<p>2.2 The Provost</p> <p>(1) The Provost shall be appointed by the Governing Body out of the panel of three persons recommended by the Search Committee consisting of the following members and shall, subject to the provisions of Sub-Section (6), hold office for a term of three years:-</p> <p>(i) an eminent professional to be nominated by the Board of Management;</p> <p>(ii) an eminent educationalist to be nominated by the Board of Management; and</p> <p>(iii) one member of the Board of Management to be nominated by the President:</p> <p>Provided that, after expiry of the term of three years, a person shall be eligible for re-appointment for another term of three years:</p> <p>Provided further that a Provost shall continue to hold the office even after expiry of his term till new Provost take charges of the office, but in any case, this period shall not exceed one year:</p> <p>Provided also that the President may appoint first Provost for a period of one year until the regular Provost is appointed under this section whichever is earlier.</p> <p>(2) The Provost shall be principal executive and academic officer of the University and shall exercise general superintendence and control over the affairs of the University and shall execute the decisions of various authorities of the University.</p> <p>(3) Where in the opinion of the Provost it is necessary to take immediate action on any matter for which powers are conferred on any other authority by or under Gujarat Private Universities Act, 2009, he may take such action as he deems necessary and shall at the earliest opportunity thereafter report his/her action to such officer or authority as would have in ordinary course dealt with the matter:</p> <p>Provided that if in the opinion of the concerned officer or authority such action should not have been taken by the Provost then such case shall be referred to the President, whose decision thereon shall be final;</p> <p>Provided further that where any such action taken by the Provost affects any person in the service of the University, such person shall be entitled to prefer, within three months from the date on which such action is communicated to him, an appeal to the Board of Management and it may confirm or modify or reverse the action taken by the Provost.</p>	

	<p>(4) Where, in the opinion of the Provost, decision of any authority of the University is not within the powers conferred by Gujarat Private Universities Act, 2009 or the Statutes, the Ordinances, the Regulations or the rules or is likely to be prejudicial to the interests of the University, he shall request the conferred authority to revise its decision within fifteen days from the date of its decision and in case the authority refuses to revise such decision wholly or partly or fails to take any decision within fifteen days, then such matter shall be referred to the President and his decision thereon shall be final.</p> <p>(5) The Provost shall exercise such power and perform such functions as may be prescribed by the Statutes or Ordinances.</p> <p>(6) The President may, on representation made or otherwise and after making such inquiry as may be necessary and is of the opinion that the continuance of the Provost in office is not in the interests of the University, by an order in writing stating the reasons therein, direct the Provost to relinquish his office from the date specified in the order:</p> <p style="padding-left: 40px;">Provided that before taking an action under this Sub-Section, the Provost shall be given an opportunity of being heard.</p> <p style="padding-left: 40px;">Note: In accordance with Sub-Section (5) of Section 15 of the Gujarat Private Universities Act, 2009, NOBLE University is pleased to declare the other powers of Provost. This declaration is made in adherence to the provisions outlined in the Gujarat Private Universities Act, 2009.</p> <p>(7) Provost shall preside over the meetings of the Academic Council and the Research Council.</p> <p>(8) The Provost shall exercise general control over the affairs of the University and shall be responsible for the maintenance of discipline in the University.</p> <p>(9) It shall be the duty of the Provost to ensure that the provisions of the Act, the Statutes, Ordinances and Regulations are faithfully observed and he shall have all the powers necessary for the purpose.</p> <p>(10) The Provost shall be entitled to call for reports from the Registrar and other Officers of the University.</p> <p>(11) The Provost shall have the power to constitute committee/s including admissions, examinations and others which he deems fit for the performance of the duties assigned to him by the Act.</p> <p>(12) The Provost shall appoint teachers / employees on adhoc or temporary basis on recommendation of Selection Committee.</p> <p>(13) The Provost shall assign the additional charge of the post as he deems necessary.</p>	
	<p>2.3 The Registrar</p> <p>(1) The appointment of the Registrar shall be made by the Chairperson of the Sponsoring Body in such manner as may be prescribed by the Statutes.</p> <p style="padding-left: 40px;">Note: In accordance with Sub-Section (1) of Section 16 of the Gujarat Private Universities Act, 2009, NOBLE University is pleased to declare the manner of appointment of Registrar. The terms and conditions of appointment of the Registrar are as follows:

- (3) The Registrar shall be the Member-Secretary of the Governing Body, the Board of Management and Academic Council but he/she shall not have a right to vote.
- (4) The Registrar shall exercise such power and perform such duties as may be specified in the Statutes or the Ordinances.

3.3 The Academic Council

- (1) The Academic Council shall be the principal academic body of the University and shall, subject to the provisions of the Act, Statutes, Ordinances and Regulations made thereunder, coordinate and exercise general supervision over the academic policies and program of the University.
- (2) The Academic Council shall consist of the following members:
 - (a) The Provost of the University shall be the Chairperson of the Academic Council
 - (b) Vice Provost
 - (c) All Deans of the Faculties of the University
 - (d) All Heads / Directors of the Institutes / Centres involved in Academic & Research activities
 - (e) One teacher from amongst all the Faculties of the University to be nominated by the Provost.
 - (f) Two eminent (external) academicians to be nominated by the Academic Council.
 - (g) One member from the Governing Body to be nominated by the Provost.
 - (h) One member from the Board of Management to be nominated by the Provost.
 - (i) Provost shall have the right to invite two eminent persons from outside the University to the Academic Council as per the requirements of the University.
 - (j) The Registrar - who shall be the Ex-officio member secretary of the Council.
- (3) The term of office of the members, other than Ex-Officio members, of the Academic Council shall be of three years.
- (4) A member may resign his office by writing under his hand addressed to the Chairperson, but he shall continue in office until his resignation has been accepted by the Chairperson.
- (5) The Academic Council shall meet as may be necessary but at least two a year and at other times when convened by the Provost or in his absence by the person holding the charge of the office of the Provost.
- (6) Half of the members of the Academic Council shall constitute the quorum for a meeting. When a meeting is adjourned for not meeting the quorum, the subsequent meeting shall have a minimum of four members present.
- (7) The decisions in the Academic Council meeting shall be taken by the majority of the votes of the members present. In case of equality of the votes, the Chairperson shall have a second or casting vote.
- (8) Powers and Functions of the Academic Council
 Subject to the provisions of the Act, Statutes, Ordinances and Regulations, the Academic Council shall have the following powers and functions; namely,

- (1) The Research Council shall consist of the following members:
 - (a) Provost (Chairman)
 - (b) Vice Provost
 - (c) All Deans of the Faculties
 - (d) Directors such as, Director of Students' Welfare and Director of IT
 - (e) All Principals of the Colleges other than Deans
 - (f) Two Eminent Scientists outside the University nominated by the Provost in consultation with Director of Research
 - (g) Special invitee/s as per requirement to be nominated by the Provost
 - (h) Project officer

- (2) The term of the nominated members of the Research Council will be for three years.
- (3) The Provost, as the Chairman, shall preside over the meetings of the Research Council and in his absence, Vice Provost or any other person nominated by the President shall preside over the meeting.
- (4) The Director of Research shall be the Member-Secretary of the Research Council.
- (5) Ordinarily seven clear days' notice shall be given for all meetings of the Research Council and the agenda papers shall be issued at least five days before the date of the meeting. The notice for emergency meetings shall ordinarily be three days
- (6) One half of the members of the Research Council including the Chairperson shall form the quorum at a meeting, provided that no quorum shall be necessary for adjourned meetings.
- (7) Powers and functions of the Research Council:
 - (a) To asses and determine the Research priorities of the University.
 - (b) To plan, execute and manage the Research activity in the University efficiently.

5.3 Application of General Fund

The General Fund shall be utilized for the following objects, namely:

- (a) For the repayment of debts including interest charges thereto incurred by the University for the purposes of the Gujarat Private Universities Act, 2009 and the Statutes, the Ordinances, the Regulations and the Rules made thereunder with the prior approval of the Governing Body;
- (b) To upkeep the assets of the University;
- (c) For the payment of the fee for audit of the funds created under sections 36 and 37 of the Act.
- (d) To meet with expenses of any suit or proceedings by or against the University;
- (e) For the payment of salaries, allowances, Provident Fund, Contributions, Gratuity and other benefits to officers, employees and members of the teaching and research staff;
- (f) For the payment of travelling and other allowances of the members of the Governing Body, the Board of Management, the Academic Council, other authorities and the members of any committee appointed by any of the authority or the Chairperson of the Sponsoring Body or the Provost;
- (g) For the payment of fellowships, free-ships, scholarships, assistantships and other awards to the students belonging to economically weaker sections of the society or research associates, trainees or, as the case may be, to any student otherwise eligible for such awards under the Statutes, the Ordinances, the Regulations or the Rules;
- (h) For the payment of any expenses incurred by the University in carrying out the provisions of the Gujarat Private Universities Act, 2009 or the Statutes, the Ordinances, the Regulations or the Rules;
- (i) For the payment of cost of capital, not exceeding the prime lending rate from time to time of the State Bank of India, incurred by the Sponsoring Body for setting up the University and the investments made therefor;
- (j) For the payment of charges and expenditure relating to the consultancy work undertaken by the University in pursuance of the provisions of the Gujarat Private Universities Act, 2009 and the Rules, the Statutes or the Ordinances made thereunder;
- (k) For the payment of any other expenses including service fee payable to any organisation charged with the responsibility of providing any specific service, including the managerial services to the University, on behalf of the Sponsoring Body, as approved by the Board of Management to be an expense for the purposes of the University.

Provided that no expenditure shall be incurred by the University in excess of the limits for total recurring expenditure and total non-recurring expenditure for the years, as may be fixed by the Board of Management, without prior approval of the Board of Management.
